I am delighted to share with you our end of Year 7 celebration plans. The year group collectively have been amazing this year and need an opportunity to socialise outside the traditional classroom environment and see some reward for their hard work and efforts throughout the year.

Parents with other pupils will know that traditionally we have tried to facilitate a visit to a theme park. With the closure of Pleasure Island some years ago, and the more recent 'downgrading' of Lightwater Valley, not to mention the lengthy queues and bus journeys to other venues, I have decided to celebrate on site this year.

Although some final details are yet to be smoothed out, the plan for the day, **Tues 9 July**, will follow similar to this:

- AM registration As normal
- Lesson 1 and 2 Interform rounders, initially planned for 10, 17 and 24 June  
Interform quiz and games
- Lesson 3 Silly Olympic event
- Lunch Option to purchase fish and chips from Welton chip shop, or the school canteen will be open as normal
- Lesson 4 and 5 A selection of inflatables and a simulator will be on the school field, with music and an ice cream van for pupils to enjoy.

There will be a cost of **£18** payable to cover the hire of the inflatables. It is envisaged that parents cover the full cost of these through a voluntary contribution. If not enough funds are raised, the celebrations may need to be reduced, or cancelled.

If your child does not wish to take part in the PM celebrations, an alternative will be provided in school, usual school uniform will be required in this instance.
